incentives for agriculture at the entity level	<p>Rulebook on conditions and manner of acquiring monetary incentives for the development of agriculture and villages (It is adopted and published every calendar year in the Official Gazette of Republika Srpska)</p> <p>In 2021, the Rulebook was published in the Official Gazette of Republika Srpska, 8/21, 17/21, 33/21, 63/21, 80/21 and 94/21</p>	<p>(1) Incentive user shall be entitled to monetary incentives for the development of agriculture and villages through the support for current production, support for capital investments, support for rural development and systemic and other forms of support.</p> <p>(2) Within the support for current production – direct support, the incentive user shall be entitled to the following types of monetary incentives:</p> <ol style="list-style-type: none"> 1) direct support for livestock production: <ol style="list-style-type: none"> 1. premium for breeding stock, 2. premium for milk, 3. premium for meat production – fattening, 4. support for beekeeping production 5. support for horse breeding; 2) direct support for plant production: <ol style="list-style-type: none"> 1. premium for produced and sold fruit and vegetables, 2. premium for produced and sold buckwheat, aromatic and medicinal herbs, 3. recourse per unit of sowing area for wheat, soy and rapeseed, 4. recourse per unit of arable area – diesel fuel, 5. premium for seed material, 6. recourse for domestic hybrid corn seeds, domestic small grain seeds, soy and grass and grass-legume mixtures, 7. premium for seedlings, 8. premium for tobacco, 9. organic production.

		<p>(3) Within the support for capital investments, the incentive user shall be entitled to monetary incentive pursuant to special regulation for:</p> <ol style="list-style-type: none"> 1) investments in livestock production, 2) investments in plant production, 3) investments in agricultural machinery, 4) investments in processing of agricultural products 5) investments in construction and equipping of fish farms. <p>(4) Within the support for rural development, the incentive user shall be entitled to monetary incentive for:</p> <ol style="list-style-type: none"> 1) support for self-employment of agronomists, 2) business activities of women's associations in rural areas, 3) business activities of agricultural cooperatives and clusters in rural areas, 4) support for agricultural cooperatives for purchase of agricultural products, 5) support for informing beneficiaries and promotion of agricultural sector, 6) support for improvement of experimental-educational and development centres, 7) support for co-funding and modernisation of hail protection, 8) support for joint projects of the Government of Republika Srpska (hereinafter: Government) and Municipality of Srebrenica, 9) support for transfer of knowledge and skills in agricultural production, 10) support for introduction of technological innovations in agriculture, 11) support for standardisation and branding agricultural production and participation in quality systems, 12) support for co-funding rural development projects, 13) support for improvement, protection and development of hunting, 14) support for preservation and protection of original breeds and strains of domestic animals in livestock breeding. <p>(5) Within systemic and other support measures, the user shall be entitled to monetary incentive for:</p> <ol style="list-style-type: none"> 1) plants health protection measures, 2) animals health protection measures, 3) support for improvement of veterinary activities, 4) support for production of seeds for artificial insemination in cattle breeding, 5) support for performing breeding and selection activities in beekeeping, 6) support for equipping laboratories, 7) support for co-funding insurance premiums of primary agricultural production,

		8) support for analysis of control of soil fertility, 9) support for analysis of control of fodder quality, 10) support for control of milk quality, 11) support for keeping and maintenance of registers, 12) support for preparation of strategic and programme documents, 13) support for implementation of audit of cooperatives, 14) support for the needs of keeping accounting data on agricultural farms (FADN), 15) support for improvement, protection and development of fish stock and operation of fish guard service and Sport Fishing Association of Republika Srpska, 16) support for emergency needs and assistance.
